### Conditions of Booking

1. Some cruises will commence at Dunstaffnage marina by Oban, although the actual time and place will be determined when you book and confirmed prior to the trip. Other trips will depart from the nominated point as on the calendar.
2. All bookings must be confirmed in writing. Telephone bookings will be held for fourteen days until a completed booking form and a 25% deposit is received. The full balance is due eight weeks before the departure date.
3. Cancellations. Clients cancelling their holiday more than eight weeks prior to their trip will forfeit only the 25% deposit. Clients cancelling less than eight weeks before their trip will be liable for all the unpaid balance. Cancellations must be made in writing. **Therefore passengers are strongly advised to have their own personal and travel insurance policy for the trip.**
4. Northern Wanderer carries third party insurance for our cruises beyond which no liability for any injury, loss or damage to personal items, loss due to cancellation or any delay caused by adverse weather conditions will be accepted. All participants accept the activity presents inherent risk
5. We reserve the right to cancel any trip if due to circumstances beyond our control we are unable to provide the charter concerned. In such case we will refund all monies paid and clients will have no further claim.
6. In matters concerning the safety and operation of the vessels **the decision of the skipper will be final.**
7. **Smoking is not allowed below decks** on the yacht.
8. Included in the price are; all services, meals taken on board, accommodation, fuel etc.
9. Not included: transport to/from the point of embarkation/disembarkation, travel insurance, and berthing and marina charges during the course of the cruise. Berthing charges will be shared equally between all guests on board.
10. Although we take bookings for individual cabins, we cannot guarantee this as we may need to rearrange berths if we get guests of unusual stature.
11. Single bookings are taken on the basis that the cabin may be shared with a guest of a similar gender.
